**RECIPROCAL RIGHTS AGREEMENT**

It is mutually agreed between the Geraldton Golf Club and the Howlong Golf Club that there should be reciprocity between our respective Clubs on the following terms:

1. Reciprocal Members are entitled to play on Reciprocal Club Competition Days by paying the competition fee applicable on the day of play and a Green Fee discounted to 50% of the advertised rate and that rate will also apply to any social or practice rounds.
2. A reciprocal member will be required upon request to provide proof of their current financial membership, residential address and handicap details (i.e. Golf Link ID card OR Letter of Introduction).
3. A reciprocal member shall be entitled to the use of all Clubhouse facilities, play in Open competitions and win a trophy, but may not win a Monthly Medal or **Closed** daily Competition or enter a Club Championship at the Reciprocal Club. **Note:** Wednesday and Saturday are generally *closed competitions at Geraldton* with prizes for members of Geraldton Golf Club only. Visitors may win a novelty (eg Nearest the Pin) or golf balls for a good score.
4. A reciprocal member may introduce a visitor subject to the application of the same rules and fees that apply to all playing members of the Club.
5. Reciprocal members are subject to the Rules, By-Laws and Policies of the Reciprocal Golf Club.
6. This reciprocity agreement shall remain in force until amended as may be mutually agreed between the two Clubs, or cancelled by either Club by giving one (1) months' notice in writing to the other Club.

## Reciprocal Rights Terms

Howlong offers to members:

Subject to the production of a valid proof of membership and subject to such qualifications, restrictions or limitations contained herein, the following reciprocal rights shall apply:

A.

1. The Pro Shop must be notified when placing your booking that you are a reciprocal member.
2. Bookings are subject to availability.
3. As a reciprocal member you may enter competitions upon payment of the competition fee plus 50% green fee; however you are not eligible to win Club Board events or Monthly Medals.
4. Reciprocal benefits apply to golf only; social membership benefits are not included.
5. Members using this reciprocal arrangement must adhere to all rules, conditions and regulations of the host Club.
6. Social play is permitted subject to availability on payment of a 50% green fee.

This reciprocal agreement shall remain in force until further amended as may be mutually agreed between the Clubs or cancelled by either Club by giving one months' notice in writing to the other Club.
