




RECIPROCAL RIGHTS AGREEMENT

It is mutually agreed between the Geraldton Golf Club and the Mauritius Gymkhana Golf Club that there should be reciprocity between our respective Clubs on the following terms:


1. Reciprocal Members are entitled to a maximum of 4 games per calendar year on Reciprocal Club Competition Days by paying the competition fee applicable on the day of play but will be exempt from paying a Green Fee.
2. Events conducted by either Club that are classed as a Major Open will not count in the 4 games
3. If a reciprocal member wishes to play more than 4 games, additional rounds will attract a Green Fee discounted to 50% of advertised rate and that rate will also apply to any social or practice rounds.
4. A reciprocal member will be required upon request to provide proof of their current financial membership, residential address and handicap details (i.e. Golf Link ID card).
5. A reciprocal member shall be entitled to use of all Clubhouse facilities, play in Open competitions and win a trophy, but may not win a Monthly Medal or Closed Competition or enter a Club Championship or Honour Board Event. **Note:** Wednesday (Women) and Saturday (Men) are **closed competitions at Geraldton** with prizes for members of Geraldton Golf Club only. Visitors may win a novelty (eg Nearest the Pin) or golf balls for a good score.
6. A reciprocal member may introduce a visitor subject to the application of the same rules and fees that apply to all playing members of the Club.
7. Reciprocal members are subject to the Rules, By-Laws and Policies of the Reciprocal Golf Club.
8. This reciprocity agreement shall remain in force until amended as may be mutually agreed between the two Clubs, or cancelled be either Club by giving three (3) months' notice in writing to the other Club.



RECIPROCAL USE OF MAURITIUS GYMKHANA CLUB

BY MEMBERS OF AFFILIATED CLUBS

The facilities and services of the **Mauritius Gymkhana Club** (hereinafter referred to as **MGC**) may be used on a reciprocal basis by Clubs' Members under the following conditions:-

- 1) Affiliated Clubs' Members must be in possession of the Club Membership Card or an introduction Letter which must be presented to the Receptionist at the **MGC**.

In case these documents are not available, **MGC** Club Manager should be contacted who will obtain confirmation from the Affiliated Club before use of the facilities and service **MGC**.

- 2) The Guest charges for the facilities and services including sports, shall be in accordance to the prevailing charges in force at **MGC**.
- 3) Affiliated Clubs' Members are not allowed any credit facilities at **MGC** and **MUST** purchase coupons for payment of facilities and services.
- 4) Maximum period allowed to Affiliated Clubs' Members is fifteen (15) days in a calendar year (January – December)
- 5) Dependent children are allowed only if accompanied by the Affiliated Club Member
- 6) Affiliated Clubs' Members are **not** allowed to entertain guests.
- 7) Affiliated Clubs' Members residing in Mauritius for a period exceeding three (3) month are not entitled to use **MGC** on reciprocal basis.
- 8) All **MGC** Rules, Bye-Laws and regulations applicable to Members of **MGC** are to be respected by Affiliated Clubs' Members
- 9) **MGC** reserves the right of refusing the use of facilities and services including sports to Affiliated Clubs' Members in case of doubt on membership, and/ or conduct, and/ or behaviour, and/ or attitude, which is not conducive to **MGC** code of conduct/ atmosphere
