RECIPROCAL MEMBERSHIP AGREEMENT

Portarlington Golf Club Inc and Geraldton Golf Club agree to offer reciprocal rights to each of their Club Members from the date of this agreement on the following terms:

- 1. Each of the Clubs shall extend to any golfing member of the other Club all privileges to the Golf Course and Club facilities usually given to its own members in the category of membership which is closest to the rights and privileges to which the member is entitled at his/her Home Club.
- 2. A visiting Member must produce an introductory card, club membership card, Golf Link card or a letter of introduction, which provides evidence of current handicap and confirms <u>full</u> financial membership of their Home Club.
- 3. The Reciprocal Agreement only provides benefits to those members who live within a 100 kilometre radius of their respective Club. Thus, a visiting Member must produce evidence of their residential address.
- 4. A visiting member shall be subject to all Rules, By-laws and other authoritative instructions of the Host Club.
- 5. All purchases for meals, drinks, etc. must be paid upon purchase.
- 6. A visiting Member may play golf at any time when the course is open for play but subject to such restrictions as may be decided by the Golf Committee of the Host Club in relation to the use of the course during social or competitive play. Such conditions also cover conditions regarding the use of motorised buggies.

- 7. A visiting Member may play in a Host Club competition and win a trophy subject to payment of the prescribed competition entry fee, but not win a Host Club Championship or Monthly Medal or major Honour Board event.
- 8. A visiting Member may take part in a Host Club Fourball Event in the company of a member of his or her Club, or of a Member of the Host Club. Except as provided in Clause 10 of this agreement a visiting member shall pay 50% of the Host Club's green fee plus the competition fee for the day.
- 9. Except as provided in Clause 10 of this agreement, a visiting Member shall pay the reciprocal members green fee specified in this agreement.
- 10. When the course at one Club is unavailable for a Members' competition because it is being used for a District Event or Annual Tournament, Members of that Club may join in a Club competition at the other Club on payment of the competition entry fee only, provided tee times are booked by the Captain of the visiting Club.
- 11. Members of Golf Link participating Clubs must produce their Golf Link card before playing in the Host Club's daily competition.
- 12. No joining rights are granted to visiting Members under this agreement and nothing in this agreement shall be construed as giving preference in joining either Club except in accordance with the terms and conditions of entry and membership as prescribed in the Rules and By-laws of each Club.
- 13. This reciprocal arrangement shall remain in force until amended as may be mutually agreed between the Clubs or terminated by either Club by giving three months notice in writing to the other Club.
