



Gailes Golf Club Inc

Terms and Conditions of Reciprocal Rights

between

Gailes Golf Club Inc.

and

Geraldton Golf Club

We, the undersigned Clubs, hereby enter into a mutual agreement whereby:

1. Each of the undersigned Clubs shall extend to any visiting Member of the other golf Club, all of the privileges of the golf course and other facilities usually given to its own Members in the Category of Membership which is closest to the rights and privileges to which the visiting Member is entitled at his/her own Club.
2. Reciprocal Members of either Club must book in advance either by phone or email providing their Category of Membership and Golfink #, as evidence of currency of Membership and GA Handicap at the Reciprocal Club.
3. The above-mentioned privileges will be exclusive of the normal green fee usually charged to visitors as described below.
 - 3.1. Reciprocal Members of Geraldton Golf Club where Gailes Members are offered a waiver on green fees will have the same arrangement at Gailes, and
 - 3.2. then 50% of advertised Green Fee for more than 6 games or any social golf, with the understanding the waiver of green fee at either Club would apply to either competition or social but limited to a maximum of 6 games.
4. Reciprocal Members shall be subject to all Rules, By-Laws, and other controls in effect at the time of their visit.
5. All purchases for Meals, Drinks, Club Hire, Motorized Cart Hire, Proshop purchases etc. will be

offered at Member rates to be paid for at the time of purchase.

6. A Reciprocal Member shall be entitled to take part in the Daily Competition upon payment of the appropriate Member Competition Fee, except in the case of Club Championships or other Honour Board events as decided by the Club from time to time.
7. Members of GERALDTON Golf Club who currently reside within a 75km radius of Gailes Golf Club in Queensland, are not eligible to make use of the Reciprocal arrangements set out in these 'Terms and Conditions'. The same restrictions apply to Members of the Gailes Golf Club who may reside in similar proximity to the Reciprocal Club named.
8. No joining rights are granted to Members of either Club under this agreement. Nothing in these rights shall be construed as giving any Member preference in joining either Club except in accordance with the terms and conditions of entry and Membership as prescribed in the Constitution, By-Laws and Rules of each Club and payments of fees determined by each Club from time to time.
9. 'Terms and Conditions' herein stated may be changed from time to time with the mutual written agreement of both Clubs.
10. This agreement shall remain in force until such time as either Club upon two (2) month's written notice terminates it.
