



## RECIPROCAL RIGHTS AGREEMENT

It is mutually agreed between the Geraldton Golf Club and the Tasmania Golf Club that there should be reciprocity between our respective Clubs on the following terms:

- 1. Reciprocal Members are entitled to a maximum of 12 games per calendar year on Reciprocal Club Competition Days by paying the competition fee applicable on the day of play but will be exempt from paying a Green Fee.
- 2. Events conducted by either Club that are classed as Open to all golfers upon payment of an entry fee only will not count in the 12 games.
- 3. Social or practice rounds may be played at the Reciprocal Club without payment of a Green Fee.
- A reciprocal member will be required upon request to provide proof of their current financial membership, residential address and handicap details (i.e. Golf Link ID card).
- 5. A reciprocal member shall be entitled to use of all Clubhouse facilities, play in Open competitions and win a trophy, but may not win a Monthly Medal or Closed Competition or enter a Club Championship or Honour Board Event. Note: Wednesday (Women) and Saturday (Men) are closed competitions with prizes for members of Geraldton Golf Club only. Visitors may win a novelty (eg Nearest the Pin) or golf balls for a good score.
- 6. A reciprocal member may introduce a visitor subject to the application of the same rules and fees that apply to all playing members of the Club.
- 7. Reciprocal members are subject to the Rules, By-Laws and Policies of the Reciprocal Club.
- 8. This reciprocity agreement shall remain in force until amended as may be mutually agreed between the two Clubs, or cancelled be either Club by giving three (3) months' notice in writing to the other Club.

## RECIPROCAL MEMBERSHIP AGREEMENT

## with Geraldton Golf Club



Subject to the restrictions, qualifications and limitations herein, we the undersigned Clubs, hereby enter into a reciprocal agreement whereby: -

- 1. Each club shall extend to its reciprocal members, all the privileges to the golf course and other club facilities usually given to its own members in the equivalent category of membership to which is closest to the rights and privileges to which the visiting Member is entitled at their own Club;
- 2. The above mentioned privileges will be exclusive of the regular fee usually charged to visitors up to a maximum of FIVE (5) days in any calendar year;
- Visiting members must produce an introductory card or their current Golf Link Card and a form of Identity
- 4. Visiting members shall be subject to all applicable Rules, By Laws and other controls of the club as in effect at the time of their visit;
- 5. Reciprocal members are not permitted to run "club" accounts. All purchases for meals, drinks, professional shop etc. must be paid for at the time of purchase;
- 6. Ulverstone Reciprocal members are required to pay comp fees applicable to Tasmania Golf Club General Members. There is no green fee applicable for social play
- 7. Reciprocal members are to pay normal visitor's rates for use of golf carts;
- A reciprocal member shall be ineligible to win club championships or to win club perpetual honour board trophies. A reciprocal member may play within the field for these events subject to vacancies and approval. A reciprocal member may win regular daily competitions;
- 9. Each reciprocal member may introduce a visitor/s on any day and such visitor shall pay the normal green fee applicable to a guest playing with a full member. Reciprocal members wishing to introduce visitors must first obtain authorisation from the Administration office;
- 10. Upon moving residential address the reciprocal member may apply for membership of the previously reciprocal club. The Committee of each Club shall consider any such application on its merits without obligation;
- If, at the time of an application and acceptance to the recipient Club pursuant to this agreement, there is no vacancy for the relevant category, the applicant shall receive priority over other applicants for membership to that category;

- 12. No joining rights are granted to members of either club, except in accordance with the rules and by-laws of each club and payment of the applicable fees;
- 13. A person elected to Membership by a Reciprocal Club under the terms of this agreement must pay, in addition to any currently applicable Subscription, the prescribed Full Entrance Fee applicable to that Membership category;
- 14. This agreement shall remain in force until such time as it is terminated by either club upon written notice.
